Bidding will be conducted through **Negotiated Procurement under Two Failures in Bidding** (Section 53.1) using non-discretionary pass/fail criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement and Reform Act".

A complete set of Bidding Documents shall be issued upon presentation of the Invitation Letter and cash payment of non-refundable fee of **P9,000.00** at the Office of the ROBAC Secretariat, 3rd Floor WLK Bldg., Veterans Avenue, Zamboanga City or at NHA Region IX Office, Bajamunde Compound, Roxas St., Sta. The NHA R IX & ARMM will hold a Pre-Bid Conference on **October 17, 2019, at 9:00 a.m.** at NHA Region IX Office, Bajamunde Compound, Roxas St., Sta. Maria District, Pagadian City, which shall be open to bidders who have purchased the Bidding Documents **ONLY**.

Submission and Opening of Bids will be on **October 24, 2019**. All bids shall be submitted not later than **9:00 a.m.** at NHA Region IX Office, Bajamunde Compound, Roxas St., Sta. Maria District, Pagadian City.

All bids must be accompanied by a bid security in any of the acceptable forms and amount as stated in the Bid Data Sheet (BDS). Bid Opening shall follow immediately after the deadline of submission of bids at the same venue. Bids will be opened in the presence of the Bidder's representatives who choose to attend at the address below. Late bids shall not be accepted.
