The NHA will hold a Pre-bid Conference on **December 8, 2017**, at 9:00 a.m. at the NHA Operations Center, 3rd Floor NHA Main Building, Diliman, Quezon City, which shall be open to bidders who have purchased the Bidding Documents **ONLY**.

Submission and Opening of Bids **will be on December 18, 2017**. All bids shall be submitted not later than 9:00 a.m. at the Operations Center, 3rd Floor, NHA Main Building, Diliman, Quezon City.

All Bids must be accompanied by a bid security in any of the acceptable forms and amount as stated in Bid Data Sheet (BDS). Bid opening shall follow immediately after the deadline of submission of bids at the same venue. Bids will be opened in the presence of the Bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.
