Addendum No. 1 – Whether submission of other documentary proof as a substitute to the required Clearance/Certificate of Remittance with statutory Obligation and of Good Standing from SSS, PAG-IBIG and PHILHEALTH (Item No. 4,5 and 6 under Instruction to Bidders (ITB) Clause 20.1 of the Bid Data Sheet) acceptable during the Submission and Opening of Bids given the difficulty in securing such from the concerned institutions?

In consideration of the limited access to SSS, PAG-IBIG and PHILHEALTH, the submission of a Notarized Affidavit of Undertaking supported by a request duly stamped and received by the concerned institutions is acceptable in case the required documents are not issued/secured in time for the receipt and opening of bids, provided that the aforesaid documentary requirements are submitted during the Post-qualification process upon determination of the bidder as the lowest Calculated Bidder.

> The Security Survey Report under ITB Clause 20.1 of the Bid Data Sheet is no longer required in the documents to be submitted by the bidder, but the bidders are encouraged to visit the site to give them a more thorough orientation of the project.
