



## REQUEST FOR EXPRESSION OF INTEREST

The **NATIONAL HOUSING AUTHORITY REGION IX & ARMM**, through the **Corporate Budget** approved by the NHA Board for the year 2021 intends to apply the sum equivalent to the Approved Budget for the Contract (ABC) to payments under the contract:

Bids received in excess of the **ABC** shall be automatically rejected at the opening of the financial proposals.

The **NATIONAL HOUSING AUTHORITY REGION IX & ARMM** now calls for the submission of eligibility documents for the above-cited project. Checklist of requirements for eligibility is available for examination upon submission of Letter of Intent (LOI) addressed to the ROBAC Chairperson and upon payment of Php7,000.00 at the **NHA Zamboanga District Office, 3<sup>rd</sup> Floor WLK Bldg., Veterans Ave., Zamboanga City**. Interested Consultants must submit their eligibility documents on or before **July 26, 2021 not later than 9:30a.m.** at the NHA Zamboanga District Office, 3<sup>rd</sup> Floor WLK Bldg., Veterans Ave., Zamboanga City. Opening of Eligibility Documents shall follow immediately after the deadline of submission of eligibility documents. Applications for eligibility will be evaluated based on a non-discretionary “pass/fail” criterion. The ROBAC Secretariat may be contacted thru tel. no. 955-5291.

The ROBAC shall draw up the short list of consultants from those who have submitted Expression of Interest, including the eligibility documents, and have been determined as eligible in accordance with the provisions of Republic Act 9184 (RA 9184), otherwise known as the “Government Procurement Reform Act”, and its Implementing Rules and Regulations (IRR). The short list shall consist of maximum of seven (7) prospective bidders who will be entitled to submit bids. The criteria and rating system for short listing are:

- a. Applicable experience of the consultant and associates, considering both the overall experiences of the firm and the individual experiences of the principal and key staff including the times when employed by other consultants;
- b. Qualification of personnel who may be assigned to the job vis-à-vis extent and complexity of the undertaking; and

c. Current workload relative to job capacity.

Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in the IRR of RA 9184 and is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines.

The **NATIONAL HOUSING AUTHORITY REGION IX & ARMM** shall evaluate bids using the Quality-Cost Based Evaluation/Selection (QCBE/QCBS) procedure. The weights to be allocated for the Technical and Financial Proposals and the criteria and rating system for the evaluation of bids shall be indicated and provided in the **Bid Data Sheet**.

The **NATIONAL HOUSING AUTHORITY REGION IX & ARMM** reserves the right to reject any and all bids, annul the bidding process, or not award the contract at any time prior to contract award, without thereby incurring any liability to the affected bidder(s).
