



INVITATION TO BID

1. The **National Housing Authority – West Sector (NHA-WS)**, through the Corporate Operating Budget for FY 2020 intends to apply the sum of the Approved Budget for the Contract (ABC) to payment for the following contract:


Bids received in excess of the ABC for each lot shall be automatically rejected at bid opening.

2. The **National Housing Authority – West Sector (NHA-WS)** now invites bids for the above Procurement Project. Delivery of the Goods is required within the specified duration per package upon receipt of the Notice to Proceed. Bidders should have completed, within five (5) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “*pass/fail*” criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.
4. Prospective Bidders may obtain further information from **National Housing Authority – West Sector** and inspect the Bidding Documents at the address given below from 10:00 a.m. to 3:00 p.m.
5. A complete set of Bidding Documents may be acquired by interested Bidders starting on **December 09, 2020** from the given address and website(s) below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **₱1,500.00** for **Ref. No. WS-2020-12-007**. The Procuring Entity shall allow the bidder to present its proof of payment for the fees in person, by facsimile, or through electronic means.
6. The **National Housing Authority – West Sector** will hold a **Pre-Bid Conference** on **December 16, 2020, 10:00 a.m.** at NHA West Sector Regional Office, Rm. 514 J&T Building, #3894 R. Magsaysay Blvd., Sta. Mesa, Manila and through video

conferencing or webcasting *via Google Meet or Zoom application*, which shall be open to prospective bidders.

7. Bids must be duly received by the WSROBAC Secretariat through manual submission at the office address indicated below and online or electronic submission as indicated below, **on or before 10:00 a.m. of December 28, 2020**. Late bids shall not be accepted.
8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 14.
9. Bid opening shall be on **December 28, 2020 at 10:00 a.m.** at the given address below and/or *via Google Meet or Zoom application*. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.

The **National Housing Authority – West Sector** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
