1. Performance security, co-terminus with the final acceptance of the project, in accordance with any one of the following schedule:
  - a. Cash or Cashier's/Manager's Check or Bank Draft/Guarantee or Irrevocable Letter of Credit issued by a Universal or Commercial bank - **Five percent (5%) of the contract price.**
  - b. Surety Bond callable upon demand issued by a surety or insurance company duly certified by the Insurance Commission - **Thirty percent (30%) of the contract price.**


The original Official Receipt evidencing payment of bond premium shall be submitted to the NHA.

2. A written authority from a senior official of your firm/organization empowered to sign the contract documents and a photocopy of his/her current Community Tax Certificate.
3. Photo copy of any competent evidence of identity such as SSS ID, Senior Citizen ID, Passport, Driver's License ID, Postal ID, COMELEC/Voter's ID, among others.

Considering that time is of the essence, failure to provide the above-cited requirements within the prescribed period shall constitute sufficient ground for cancellation of the award and forfeiture of the bid security and shall be construed as a waiver on your part to accept the award of the contract without further written notice.

Commencement of the works shall be undertaken not later than the seventh (7th) day from receipt of the copy of duly executed contract and complete the same within **190 calendar days** upon receipt of **Notice to Proceed**, unless an extension is granted in writing or the contract is earlier terminated.
