6. Proposals must be delivered at the NHA Regional Office IX, Block 8 Lot 2, Pres. Corazon C. Aquino Regional Government Center, Balintawak District, Pagadian City, Zamboanga del Sur on June 21, 2022 not later than 10:00 AM. All proposals must be accompanied by eligibility documents as required. Late submission of proposals shall not be accepted.

6. Proposals shall be evaluated using the Quality-Cost Based Evaluation/Selection (QCBE/S) procedure.

7. The NHA reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41. Reservation Clause of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
