



**ROBAC Resolution Recommending Award through
Negotiated Procurement – Small Value Procurement**

WHEREAS, the National Housing Authority (NHA) through the East Sector Regional Office Bids and Awards Committee (ESROBAC) initiated the procurement activity through Request for Quotation Ref. No. PMMDO RFQ No. 2022-001: **Procurement of Supply of One (1) Validating Machine for Pasig/Marikina/Manggahan District Office** from suppliers pursuant to the Section 53.9: Negotiated Procurement – Small Value Procurement of 2016 Revised Implementing Rules and Regulations of Republic Act 9184;


