

EAST SECTOR ROBAC RESOLUTION NO. 2022-018 (GOODS)

WHEREAS, the National Housing Authority (NHA) through the East Sector Regional Office Bids and Awards Committee (ESROBAC) initiated the procurement activity through Request for Quotation Ref. No. 2022: ESO-RFQ-2022-002 **Procurement of Computer Consumables (Inks, Toners, & Cartridges) for the Use of NCR-East Sector Office** from suppliers pursuant to the Section 53.9: Negotiated Procurement – Small Value Procurement of 2016 Revised Implementing Rules and Regulations of Republic Act 9184;

WHEREAS, the above-cited project has an Approved Budget for the Contract (ABC) amounting to **Four Hundred Seventy Four Thousand Three Hundred Seventy Two and 67/100 Pesos (Php 474,372.67)**;


